DAYCARE CHARGES

Part time: All UGCS students can attend before and after school daycare for a minimal charge. Before school daycare ends at 7:45 A.M. After school daycare begins at 3:15 P.M. Students on the property before 7:45 A.M. or after 3:15 P.M. are subject to daycare charges.

Daycare: Opens at 6:30 A.M. and closes at 6:00 P.M.

Fulltime: Rates include tuition, before and after school care and daycare when school is closed, but daycare is open.

FULL-TIME DAYCARE CHARGES

Weekly – K3-K5 - \$100.00 (1st Child)

Weekly – 1st-6th - \$110.00 (1st Child)

PART TIME DAYCARE CHARGES

Part Time Hourly - \$6.00 (maximum \$36.00/day)

DAYCARE ACCOUNTS

- Full-time tuition/daycare payments are to be made on Monday of each week and must be kept current.
- **When children are picked up after 6:00 P.M. there will be a \$5.00 charge for the first 15 minutes and \$1 each additional minute thereafter.**

DISCOUNTS

- A 15% discount will be given to any family with two or more enrolled children.
- A 5% discount will be given to regular attending members of Union Grove Baptist Church.
- A 2% discount will be given if tuition is paid in full by September 1.
- A 5% discount will be given off of a currently enrolled student's tuition for every new family that is recruited for the 2012-2013 school year. The parent/guardian of the new registrant and the family referring the new registrant must complete a form to request the discount.
- A 15% pastor/missionary discount for those employed by a church or Para Church ministry in a fulltime position.

**Multiple discounts will be calculated independently from each other.
