Registration: \$50 (*per child, non-refundable*)

Part-time:

Part time charges are billed at an hourly rate of \$7.25/hour or a daily rate of \$40/day. Parents should inform the office in advance of the days and hours students are planning to attend.

Full-time:

\$120/week First Child
\$110/week Second Child
\$100/week Third Child

Field Trip costs are included in weekly fee. All fees are due on Monday of the week attended by the child. Students will not be allowed to attend if account falls 1 week behind. A late fee of \$1.00 per minute will be charged if a student is picked up after 6p but before 6:15p. A \$5 per minute late will be charged for each additional minute after 6:15p. Each full-time student may miss one week (M-F) without charge during Summer Day Camp. There is a \$30 returned check fee.

Summer Day Camp Policies and Information

Purpose

Union Grove Christian School is a ministry of Union Grove Baptist Church. We emphasize Christian values and patriotism. Attendance at Union Grove Christian School's Summer Day Camp is a privilege and not a right. Our goals are not to reform or baby-sit, but to train Christian youth in the highest principles of Christian leadership, self-discipline, individual responsibility, personal integrity, and good citizenship. Our school stands without apology for the Gospel of Jesus Christ and the highest standards of morality and Christian behavior.

Admissions Policy

UGCS admits students of any race, color, and national and ethnic origin to all of the rights, privileges, programs, and activities generally accorded or made available to students. It does not discriminate on the basis of race, color, and national or ethnic origin in administration of its educational policies, admissions policies, or other school administered programs.

All children must be fully toilet trained and may not wear pull-ups.

Attendance Options

Both part-time and full-time options are available during the summer. A student is considered part-time if he attends one or two days per week. A student who attends three or more days a week is considered full-time. A part-time student may at any time during the summer change to full-time. Once a student is enrolled as full-time, he may not return to part-time status.

A one-week (M-F) unpaid, unattended, vacation is allowed for each child during Summer Day Camp. Please inform the school office prior to the week of vacation to avoid charges.

Discipline

Orderly conduct and a pleasant environment are impossible without discipline. Each teacher will explain to the children how she expects them to behave. If a child disobeys, he will be taken aside and the teacher will explain to him what is expected to make sure he understands. The next time he is disobedient, he will have to sit in time out or miss part of an activity. Alternatives can be used at the discretion of the teacher. If the child continues to disrupt the class or shows an attitude of aggression or an uncooperative spirit, the parents will be called to help discipline the child.

UGCS does not use corporal punishment as a form of discipline. In addition, no child shall be handled roughly in any way including shaking, pushing, shoving, pinching, slapping, biting, kicking, or spanking. No child shall ever be placed in a locked room, closet or box. Discipline shall in no way be related to food, rest, or toileting.

Dress

The goal of the dress code is modesty. We ask that the parents help by requiring modest dress for the students. The following list of items is not exhaustive, but serves as a guideline:

1. No skimpy play outfits or two-piece bathing suits will be allowed.
2. Clothing should not bear pictures or symbols related to rock music or inappropriate product advertisement.
3. Shorts and pants should be hemmed with no frayed edges. Rock, punk, or fad hairstyles and jewelry are not permitted.
4. Boys' hair should be neat and trimmed.
5. Shorts, skirts, and dresses should not come more than 2 inches above the knee. Blouses and shirts are not to be sheer or tight fitting.
6. No tank tops or spaghetti-strap tops are allowed.

Financial Policy

Full-time charges are due each Monday during the summer. Part-time charges are due on the first day of attendance during the week. It is important that all accounts be kept current. If an account is more than ONE week behind, the student will not be allowed to attend.

There is a \$30 service fee for each returned check. If a check is returned, the account may be given a cash-only status.

Food

Lunch is included in your weekly or daily day camp fee. Please see the calendar for the daily menu. If your child does not like what we are having it will be up to you to provide for them. If you send a lunch on a fieldtrip day it must be in a disposable container (no thermos, lunch boxes, re-usable containers, etc). Milk is provided during lunch for the students in the 3-5 year old classes.

Morning and afternoon snack is also provided for the 3-5 year old classes. Elementary age students will be given an opportunity to eat a snack if they choose to bring one from home. We will occasionally have specials such as popcorn, ice cream, and cookies for sale. Notes will be sent home about these weekly.

Hours of Operation

Summer Day Camp operates Monday – Friday from 6:30a until 6:00p. A late fee of \$1 will be charged if a student is picked up after 6:00p but before 6:15p. A \$5 per minute late fee will be charged for each additional minute after 6:15p. Emergencies will be taken into consideration. Parents should call 764-3105 ext. 309 if they know that they will be late for pick up.
